## Call for Nominations

***The Fifth Annual Professional Development Awards***  
in collaboration with  
**the NJ Association for the Education of Young Children (NJAEYC)**  
and the  
**NJ Statewide Coalition for Child Care**

The four awards\*, to be presented at the NJAEYC Annual Conference in Atlantic City on Saturday, October 23, 2010, are as follows:

- 1) *The Becker Brothers Professional Development Award* for a child care program director/administrator or school age director/administrator who recognizes and promotes professional development within his/her program.
- 2) *The Lakeshore Professional Development Award* for a child care program staff member or school age staff member who exemplifies dedication and determination in advancing his/her own professional development.
- 3) *The Kaplan Professional Development Award* for a family child care provider who exemplifies dedication and determination in advancing his/her own professional development.
- 4) *The School Specialty Newcomer Recognition Award* for a teacher/provider/caregiver just beginning in the field who exhibits the qualities of a future leader.

### **Rating Criteria (points awarded for each criterion met)**

A nominee should be someone who:

- a) Works in an early childhood program or family child care home that is accredited or in the process of seeking accreditation.
- b) Participates in *The NJ Registry for Childhood Professionals Serving Children Birth Through Age Thirteen*.
- c) Has made an investment in his/her professional development above and beyond licensing and registration requirements.
- d) Supports the professional development of others through CDA advisement, offering trainings, mentoring others etc.
- e) Demonstrates advocacy and leadership for children and families (e.g. follows the NAEYC *Code of Ethical Conduct*).
- f) Contributes through community involvement (e.g. participation on local, county, state, or national level governing or advisory boards, community coalitions, NJAEYC membership, local NJAEYC affiliate activities, etc).

The awardees will be determined by the Professional Impact NJ Communications Committee which is comprised of volunteers from the early childhood community, members of NJAEYC and Professional Impact NJ staff.
